We believe in this instance, a cigar might have been discarded in the mulch by a person renting the home. MULCH IS FLAMMABLE.... AND SNEAKY!

Mulch can smolder for hours under the right conditions. Much later a flame can occur. In this instance, when smoke and flame was noticed, the renters were away from the home and had no idea of the consequences. If gone unnoticed, this "minor" infraction could have become a nightmare.

Homeowners, PLEASE DO NOT ALLOW OPEN FIRES AT YOUR HOME. PLEASE PROVIDE A CIGARETTE CHIMNEY OR A BUCKET OF SAND ON PORCHES AND DECKS. CLEARLY INDICATE THOSE RULES TO YOUR GUESTS. IF YOU RENT YOUR UNIT, INDICATE THOSE RULES TO THE AGENCY YOU USE FOR BOOKING.

Improved Wildfire Situational Awareness capability is now available. Your Community Wildfire Protection Committee (CWP) wants you to know of a new Wildfire Situational tool that has just become operational. For the last year, we have been tracking the pending introduction of a Wildfire sensor camera on the Cline Buttes high terrain. Notably, in the last two weeks, the Cline Buttes camera has come online. This camera joins a network of active cameras in our Region. The camera system provides an extraordinary situational awareness tool for many entities in our immediate area.

To access the camera internet site, go to https://www.alertwildfire.org/. Under "Regions" in the menu on the left side of the page, select "OR, ID & WA", then look for the "Cline Butte" camera thumbnail below the main camera pane. You will be viewing the virtual image from the camera in real time as the camera scans 360 degrees. Also, it is suggested that you look at the home page menu and select and view "Help and Support." This option provides good information as well as links to other related sites. Remain Vigilant and Fire Safe!!

Call for Candidates....Please consider becoming part of the solution. Candidate nomination are open until October 4. You can self-nominate for one of five Board Positions. You must live within the Voting Group you select. Term lengths for each are indicated below:

- Two positions from Voting Group 1 One position is a 2-year term and one position is a 3-year term. Voting Group 1 is defined as "single-family residential homesites with custom or semi-custom homes," specifically: Eagle Ridge homesites, Highland Ridge homesites, The Falls, Scenic Ridge and Eagle Springs.
- One position from Voting Group 2 This position is a 3-year term. Voting Group 2 includes the Creekside, Forest Greens, Forest Ridge neighborhoods.
- One position from Voting Group 3 This position is a 3-year term. Voting Group 3 includes the Homesteads of Desert Sky, Vista Rim, Highland Parks and Eagle Creek neighborhoods.

 One position for At-large – This position is a 1-year term. Any RECOA owner is eligible.
